**PICK-A-DILLY CRAFT FAIR**

The United Methodist Women of St. Peter's United Methodist Church is sponsoring the Pick-a-dilly Craft Fair. It will be held on Saturday, October 20, 2012, from 9:00 a.m. to 4:00 p.m., just in time for Halloween, Thanksgiving, and Christmas! This will be our twenty second year for the fair. Each year our fair gets bigger and better! We look forward to you joining us for this festive event!!!

The inside booths are available for \$50, and the outdoor booths are \$40. A donated item will be collected for our silent auction. For all 2011 exhibitors, I will hold your space, if requested until August 15<sup>th</sup>. We are in the midst of a capital campaign and some reconfiguration within the church walls may make this impossible. After this date, space assignment is on a first reply basis. Booth assignments will not be made until payment is received. A 10% surcharge applies to applications received after September 1, 2012.

Booth size is *approximately* 8' by 10'.

Many outdoor booths under the covered walkway are 12.5' by 5'

Space is available on the lawn. Vendors may provide their own canopy.

Electricity is available at some inside and outdoor booths

***DISPLAY TABLES ARE NOT PROVIDED.*** Chairs are available indoors.

We welcome national brands to present their merchandise. However, we limit it to *one* vendor per national brand product. Representatives of national brands must follow all guidelines as set forth by the company they represent.

The Pick-a-dilly will be highly publicized and we are anticipating a great show this year. We are an established fair in the West Houston and Katy area. We look forward to hearing from you. Please send your completed exhibitor's agreement and your check payable to St. Peter's UMW to the address above.

If you would like the confirmation letter to be mailed to you please enclose a self-addressed, **stamped** envelope, otherwise it will be sent to you through an e-mail.

**ENTRY DEADLINE IS SEPTEMBER 1, 2012** Applications received after this date will be subject to a 10% surcharge. No refunds will be given for inclement weather or cancellation after September 15<sup>th</sup>. We will consider this a donation to the United Methodist Women's missions. Thank you.

## **RULES OF THE SHOW**

The following regulations will govern exhibitors at the Pick-a-dilly Craft Fair:

**APPLICATION:** The sale of exhibit space will be the sole responsibility of management. Application for exhibit space will be made by mail by executing and returning the forms along with a check for the full amount of the exhibit space to the address indicated. Your confirmation will be sent to you upon receipt of your check.

**BOOTH SET-UP:** Booth assignment is at the discretion of the show management. Space may be altered at the discretion of show management. Booths will be assigned strictly on a first reply basis determined by postmark of your contract. *Assignments will be given the morning of the show beginning at 7 a.m.* Look for the information booth outside the Lott Fellowship Hall.

**SET-UP TIME:** The exhibit area will be open for set-up at 7:00 a.m. on Saturday, October 20, 2012. All exhibits must be ready to open by 9:00 a.m.

**EXHIBIT HOURS:** The Pick-a-dilly Craft Fair will be open from 9:00 a.m. until 4:00 p.m. on Saturday, October 20, 2012.

**MOVE OUT SCHEDULE:** Exhibitors may take down their items between 4:00 p.m. and 6:00 p.m. on Saturday, October 20. The exhibit area must be cleared by 6:00 p.m. There can be NO exceptions to this rule. Please do not close your booth early due to the traffic control, safety, and courtesy of the other exhibitors. There are approximately 100 booths.

**SECURITY:** Exhibitors are not guaranteed against loss or damage. Do not leave items unattended inside or outside the buildings. Management is not responsible for loss.

**ALCOHOL CONSUMPTION AND SMOKING:** No smoking or consumption of alcoholic beverages will be allowed in the exhibit area.
